- (3) Closing Date, the Reporting Person received the right to acquire 610,333 shares of the Issuer's Common Stock in connection with the Business Combination, (i) 332,909 of which will be released from escrow if the value weighted average price ("VWAP") for at least 20 of any 30 consecutive trading days following the Closing Date is at least \$12.50; and (ii) 277,424 of which will be released from such escrow if the VWAP for at least 20 of any 30 consecutive trading days following the Closing Date is at least \$15.00. Any shares not eligible to be released within five years of the Closing Date will be forfeited and canceled.
